

Office of Peace, Justice and Integrity of Creation – February 2014 PJIC Update



Promoting empowerment of people in achieving poverty eradication, social integration, and full employment and decent work for all was the theme of 52nd Session of the UN Commission on Social Development (February 10-21). Nine sisters representing five Federation congregations are in picture on left. The Sisters of Charity Federation was one of many NGOs and CSOs that approved the 2014 Civil Society Declaration at the beginning of the session. Recommendations focused on: social protection floors; guiding principles on extreme poverty and human rights, legal empowerment

of all people; formal and informal quality education; expansion of innovative sources of financing for development that prioritize public financing over public-private partnerships; and, special note of the 20th anniversary of the International Year of the Family. There is a movement towards establishing post-2015 Sustainable Development Goals (SDGs), successor to the Millennium Development Goals, which are holistic, inclusive, participative, equitable and universally applicable as well as measurable and monitored. Months ago Sr. Cj Willie invited us to answer *The United Nations Global Survey for a Better World*. Some of us did! As work continues on the SDGs at the UN level, may we be more conscious of the possibilities, promise and power that exist through personal, Congregational, Sisters of Charity Federation and Vincentian Family involvement in eliminating poverty and creating the World We Want!

Farmer Dave Hambleton’s excellent presentation to the Sponsorship Advisory Council at its February 1 meeting was a reminder to Sr. Carol that SCNY sponsored works are actively engaged in systemic change – each one in a unique way. Here is how Sr. Claire Regan expresses it: “So often we speak of structural change and think specifically about social or legal systems. Through the Creation’s Transformative Energy Task Force, I have come to see that lifestyle change is also structural change. An example of the lifestyle change

toward buying locally and buying healthily is expressed through the working of Sisters Hill Farm. Here, methods that do not use pesticides and that use time honored as well as innovative techniques of land management and soil replenishment, as well as practical methods of education have been spread by the students and shareholders across the area, State, and Nation. Change happens through people and relationships. The changes spawned through the work of Sisters Hill Farm are in alignment with a broadly sweeping awareness of the need to ‘make change’. Earth speaks her gentle assent to this movement of grace.”
